WV Senate Committee Approves Bill Curbing Infrastructure Protests

The West Virginia Senate Judiciary Committee approved by a voice vote on March 4 a bill that would establish as a misdemeanor an action by "any person who willfully and knowingly trespasses or enters property containing a critical infrastructure without permission." A similar measure passed the WV House of Delegates by a 65-30 vote on February 13. The bill defines "critical infrastructure" to include natural gas pipelines and compressor stations.

The <u>Senate Judiciary's version of the bill</u> has somewhat lower fines applied to the cited offenses and exempts actions deemed to be exercises of free speech, including "protesting and picketing." The full Senate is expected to take up the bill before the Legislature's scheduled adjournment by Midnight, March 7.

New FERC Member Approved by Senate Judiciary Committee

James Danly, general counsel for the Federal Energy Regulatory Commission (FERC), who was nominated in October by President Trump to become a member of the Commission, filling a Republican vacancy on the Commission, was approved by the Senate Energy and Natural Resources Committee on March 3. Should Mr. Danly be confirmed by the full Senate — which is expected — FERC will then have a 3-1 Republican majority. One of those Republican members, Bernard McNamee, whose current term expires in June, has indicated he will not seek reappointment. Mr. Danly's nomination was approved on a 12-8 vote with all 11 Republican members plus Ranking Minority Member Sen. Joe Manchin (D-WV) voting to confirm.

Sen. Manchin, while supporting Mr. Danley's nomination, expressed frustration that the White House has yet to nominate someone to fill the remaining Democrat seat on FERC, which became vacant last August with the departure of Commissioner Cheryl LaFleur. In a <u>statement</u> released after the vote, Sen. Manchin said:

"I am disappointed we are advancing the nomination for the Republican seat on the Federal Energy Regulatory Commission without pairing Mr. Danly's nomination with a nomination to fill the Democratic seat that has been vacant since last August.

"Unless we fill the vacant Democratic seat, we will again be faced with a bare quorum of three Commissioners even after Mr. Danly is confirmed, once Mr. McNamee's term expires. Moreover, filling the Republican seat while leaving the Democratic seat vacant is not in keeping with the longstanding practice of this Committee or the need to keep the Commission bipartisan."

Virginia Creates a Permanent Environmental Justice Council

Virginia Governor Northam on March 3 signed into law a bill creating the Virginia Council on Environmental Justice. The measure, HB 1042, had passed the House of Delegates February 3 by a 55-43 vote, and passed the Senate on February 17 by a 25-15 vote. Previously, an Environmental Justice Council existed under a Governor's Executive Order.

The new Council will have 27 members, consisting of 21 non-legislative members appointed by the Governor and six ex officio members who are cabinet members or their designees. The stated purpose of the Council is to "advise the Governor and provide recommendations that maintain a foundation of environmental justice principles intended to protect vulnerable communities from disproportionate impacts of pollution."
